TYPES OF CATEGORY:

(I) CATEGORY 1 | ACADEMICS:

FOR STUDENTS WHO HAVE SHOWN A SUSTAINED LEVEL OF OUTSTANDING ACADEMIC ACHIEVEMENT. TO BE ELIGIBLE TO APPLY, STUDENTS APPLYING TO A PARTICULAR GRADE MUST MEET THE FOLLOWING 'MINIMUM ELIGIBILITY CRITERION'

BOARD	Minimum Eligibility Criterion
CBSE	80% and above
ICSE	80% and above
WB Board	70% and above
Any other recognized board/ university	80% and above

(II) CATEGORY 2 | SPORTS:

FOR STUDENTS WHO HAVE CONSISTENTLY SHOWN OUTSTANDING MERIT AND ACHIEVEMENT AT NATIONAL AND INTERNATIONAL LEVEL SPORTING EVENTS & TOURNAMENTS.

(III) CATEGORY 3 | ARTS:

FOR OUTSTANDING AND GIFTED STUDENTS IN THE FIELD OF 'ARTS' WHO HAVE CONSISTENTLY PRODUCED AN EXCEPTIONAL QUALITY OF WORK AND SHOWN OUTSTANDING MERIT AND ACHIEVEMENT AT NATIONAL AND INTERNATIONAL LEVEL EVENTS.

(IV) CATEGORY 4 | NEED:

FOR STUDENTS SEEKING ADMISSION BELONGING TO LOWER INCOME GROUPS SHALL BE PROVIDING GENEROUS CONCESSIONS. STUDENTS IN NEED OF CONCESSION SHOULD SUBMIT A WRITTEN APPLICATION ALONG WITH RELEVANT DOCUMENTS AT THE TIME OF REGISTRATION.

****TERMS & CONDITIONS APPLICABLE:**

- ALL SCHOLARSHIPS GRANTED ARE REVIEWED ANNUALLY AND ARE BASED ON THE CONTINUED PERFORMANCE OF THE AWARDEE. THE MANAGEMENT RESERVES THE RIGHT TO CANCEL A STUDENTS SCHOLARSHIP ANYTIME DURING THE PERIOD OF CONTINUED STUDY.
- IN CASE ANYSCHOLARSHIP IS AVAILED ON THE BASIS OF MISREPRESENTATION OF DOCUMENTS OR FALSIFIED CLAIMS, THE SAME SHALL BE PAYABLE ALONG WITH PENALTY BY THE STUDENT (/GUARDIAN).
